NOTICE OF SELECTIVE SERVICE SYSTEM UNREGISTRATION FORM

Dear SELECTIVE SERVICE SYSTEM - GENERAL COUNSEL,

TAKE CONSTRUCTIVE NOTICE to Please unregister me from SELECTIVE SERVICE SYSTEM immediately, cancel all instruments and collections, and cancel all created debt under authority of UCC 3-604 (a).

All status and rights derived are heretofore null and void, ab initio. I certify, under penalty of perjury, that I am not, nor ever was, a US Citizen (legal presence), am not, nor ever was, a resident in the UNITED STATES (as defined by Title 26 USC §7701 (9) & (10)), and am not, nor ever was, eligible for Selective Service System registration as a **non-immigrant non-resident non-legal alien;** and was duped by the UNITED STATES, and subsidiaries, through fraud and misrepresentation to unlawfully register with SELECTIVE SERVICE SYSTEM.

Furthermore, please inform of unregistration and revoke all information passed to the Dept. of Justice, Dept. of State & U.S. Citizenship and Immigration Services, Dept. of Defense & US Coast Guard, Dept. of Labor, Dept. of Education, Office of Personnel Management & US Postal Service, Dept. of Health and Human Services, all State and Local Governments, Bureau of Census, Alternative Service Employers, and the General Public.

Send the receipt of unregistration to my address within the next three (3) business days. Silence on these matters is consent and evidence of execution of this notice.

American Communications Association v. Douds, 339 U.S. 382, 442 (1950) provides: "It is not the function of our Government to keep the citizen from falling into error; it is the function of the citizen to keep the Government from falling into error." If you believe that you cannot or will not unregister "me" from your Selective Service System or that there are no statutes providing for the unregistration, you are in error and i am correcting your error in presumption that you cannot unregister "me." You absolutely can and lorder it be done immediately, with receipt, under UCC §3-604 (a), where by you maintain negotiable instruments "in my legal name" that must be discharged by cancellation IMMEDIATELY BY MY ORDER due to identity fraud used to induce fraudulent registration with the Selective Service System and usage of such negotiable instruments to unlawfully fund the WAR TIME BELLIGERENT STATE of the United States via United Nations. I was never required to register and do not consent to nor contract with the United States/United Nations nor Selective Service Systems. All Presumptions of legal presence must cease and desist immediately.

For use by any Registered World Citizen with a World Citizen Birth Certificate to Unregister.

INSTRUCTIONS

This form is for unregistering from the Selective Service System due to being a World Citizen and never being a US Citizen nor US Resident. Only legal presences (fictions) are US citizens and reside in the legal fiction called United States. No natural living human has ever been "living" in the United States unless in Washington, DC. Title 26 USC §7701 (9) & (10) define the United States as ONLY and nothing but Washington, DC.

This form may be sent by mail, fax, and/or email to the Selective Service System Headquarters General Counsel.

The Selective Service System will do everything in their power to NOT perform the unregistration because they create debt instruments to fund wars by our authorization. Every time I have called Selective Service, they get angry, upset, and hang up the phone from this notice of unregistration process. In the bits of conversation that have been useful, they told me to file the request in writing with proof of Non-US Citizenship, and Proof of never having lived in the United States. The only method to prove a negative is by AFFIDAVIT, which this form contains.

To not process this notice, they would need to file a rebuttal affidavit claiming that you are a US Citizen and/or DO live in the United States. If they do not respond with an AFFIDAVIT, their denial is unlawful and it is recommended that you do not accept their false claims that they cannot follow the Notice of Unregistration. Their silence is confirmation that they accepted and processed this notice. This is where the USPS Return Receipt is useful as proof of them receiving the document.

If they do not unregister you, Natural Law will hand the governmental corporation and its agents a dose of reality.

To confirm unregistration, you can verify their Selective Service Number on their website documented in the next section.

HOW TO FILL OUT THIS FORM

To fill out this form, you will need the Selective Service System (Instrument) Number and original date of registration. To get this information go to their website and fill out your last name, their Social Security Number for you, and your date of birth at:

You will also need your World Citizen Birth Certificate from the World Service Authority operating the World Government of World Citizens. If you do not have a World Citizen Birth Certificate, then you may register to be a foreign alien in relation to the United States by going to:

To complete this form:

Fill in the Selective Service Number in Box 1.

Fill in the Selective Service Date of Registration in Box 2.

Fill in your Last name in all UPPER CASE in Box 3.

Fill in your First Name and Middle name in all UPPER CASE in Box 4.

Fill in your Date of Birth in Box 5.

Fill in your World Birth Certificate Number in Box 6 to verify to the Selective Service System that you were born outside the United States at the World and are a non-resident non-immigrant alien.

Fill in your return receipt address into Box 7. Your address

MUST be zip code exempt and not use abbreviations. For example:

c/o 123 Main Street, non-domestic Keene, New Hampshire [zip code exempt, near 03431] North America, World

Fill in the Date of sending the document in the first underlined section and method of service (mail, fax, email, etc) in the second underlined section to complete the PROOF OF SERVICE statement.

Lastly, sign, date, and file with Selective Service System. To sign digitally, prepend the text "/s/" before the signature. (e.g. "/s/ John Q Doe©", "/s/ John-Q: Doe© representing DOE, JOHN Q.©"). You may want to consider signing with a notary to bullet proof the unregistration.

HOW TO FILE

Once the data is properly entered onto the form, Sign the Form and date. You may optionally notarize your signature to ensure legal validity. Then fax, email, and/or mail the form to Selective Service System at:
